


Benefits of Permit Automation

- Average permit turnaround time **decreased to minutes** for routine OS/OW loads
- **30+ states** report moderate increase in applications and issuance
- Accurate permits = Safer transport
- Additional permits = Additional revenue
- Improvements to infrastructure preservation
- **Reduced** overhead for public agencies = greater flexibility for staffing priorities =
- Better customer service





Auto-Issue Single Trip Weight & Dimension Thresholds





Permit Harmonization

- Seek solutions less restrictive or status quo, not more restrictive
- **Balance** consistency while maintaining safety
- **Recommend** voluntary harmonization, **not** mandatory uniformity
- **Phase I** and **Phase II** baselines adopted by AASHTO and implemented by many states
- SC&RA and AASHTO will revisit Phase III post COVID-19

- Night Movements
- Route Surveys
- Standardization of Application Information
- Multi-State Corridor Communication
- Communication between States and Industry
- Electronic Verification of Permits



COVID-19 Industry Impact


- British Columbia Trucking Association survey:
 - Majority reported loss of revenue year over year resulting from the pandemic
 - **20.5%** for motor carriers
- Ecommerce maintains demand for carriers and logistics providers servicing that industry, *"with strength in retail and home construction, but continued weakness in industrial freight*."
- Wage subsidies reduced layoff impacts for U.S. and Canadian carriers
- Reduced revenue, accompanied by increased costs for training, cleaning, and PPE for drivers for Pandemic protocols.
- Ongoing challenges relating to border crossing, physical distancing, quarantine and family time, and freight volumes.
