Covid Measures/Response

- Weekly/ad-hoc calls with stakeholders
- Implemented a range of Covid measures in collaboration with PHAC, CBSA. ESDC, PSPC and industry to support trucking industry
 - Establishing truck drivers as essential workers
 - Regulatory exemptions to Hours of Service regulations;
 - Essential worker employment confirmation letters to facilitate inter-provincial and international border crossings and access to facilities;
 - Federal safety guidance to protect drivers and limit the spread of COVID-19 in commercial vehicle operations;
 - Practices for the Use of Masks, Face Coverings and Gloves
 - Facilitating/advocating availability of and access to rest stops

Dec 1, 2020

ELDs and Hours of Service Regs.

- Amendments to the federal HoS Regulations mandating ELDs go in effect on June 12, 2021.
- Amendments did not alter the core HoS work and rest requirements set in the Regs.
- Testing and certification regime for ELDs is supported by extensive technical specs and test procedures.
- As per regulations ELDs have to be tested and certified by accredited certification bodies (CBs).
- The first CB, FPInnovations was accredited by the Minister on October 15, 2020 and process for ELD certification has commenced.
- Most P/Ts are pursuing their own ELD mandates and consultations. Some started work on legislative and regulatory amendments as well.

Task Force on HDV Retrofits

- The Task Force on Heavy Duty Vehicle Retrofits was formed out of a commitment made under the Pan Canadian Framework on Clean Growth Climate Change
- It has been mandated to produce two reports:
 - Phase 1 report a landscape document describing the current state of fuel saving retrofit technologies.
 - Based on the landscape document, the TF will explore policy options under the 2nd phase.
- Phase 1 report is nearly complete and we are currently thinking about how to define Phase 2 which would focus on encouraging the uptake of retrofits.

Zero Emission MHDVs

- Speech from the Throne Climate action will be a cornerstone of government's plan to support and create a million jobs across the country.
- As part of the plan, zero-emission vehicles will be made more affordable while investing in more charging stations across the country.
- Transport Canada (TC), and other departments, continue to explore federal initiatives that will help increase the adoption of zero emission medium and heavy duty trucks.
- TC plans to engage stakeholders on this initiative in the near future.

Truck Driver Shortages

- TC is aware of the labour shortage faced by trucking industry in the supply chain.
- Engaging with federal partners such as ESDC, ISED, and IRCC, and industry stakeholders, including HR Trucking, to identify strategies to address shortages.
- Speech from the Throne recently announced increased investment in skills training and employment. TC is working with ESDC to ensure this can benefit the trucking industry and drivers as well.
